Sub: Clarification /Confirmation on news item appearing in "Media/Publication" in "https://www.moneycontrol.com/n" dated February 11, 2020 captioned "Titan acquires HUG Innovations, launches smart watch"

This is with reference to the above clarifications sought from the Company vide letter dated 12th February 2020 bearing subject Clarification /Confirmation on news item appearing in "Media/Publication". In this regard, we wish to clarify as under:

- 1) The Company has purchased a patented technology in the field of Advance Gesture Recognition technology from HUG Innovations Inc. (HUG Innovations). It is further clarified that the Company has not purchased HUG Innovations as the transaction was only limited to the extent of purchase of the said technology from HUG Innovations and hiring its entire team.
- 2) The above fact has also been disclosed in the Company's quarterly update released to the Stock Exchanges on 4th January 2020 under the heading 'Watches & Wearables' Division update for the quarter ended 31st December 2019. The relevant portion of the above transaction as disclosed in the said communication is reproduced below for ready reference:
 - "The Division has been focusing on the wearables category over the last few years and in this connection acquired patented technology in the field of Advance Gesture Recognition technology from HUG Innovations Inc. and has also hired the entire team in India effective 1st January 2020. Hug Innovations had earlier launched 4 products Hug Smartwatch, Hug Elan, Hug Fit and MyBuddy. It was recognised amongst the Top 10 Innovative start-ups in the world at Mobile World Congress, Barcelona."
- 3) The Company has been in the wearables and smart watch business for several years and in this respect, the Company has, in the past, engaged with various technology partners to build capacity for various wearable product launches.
