

In response we had intimated him regarding the lodgement of said shares and requested him to verify his old records for the sale of the said shares. In case, he still wishes to claim the shares, he will be required to settle the matter with the lodgers.</p> <p>Mr. Das was able to settle the matter in respect of 100 shares of Rs.10/- each in 2012. Vide letter dated 03.09.12 received on 17.09./12, Mr. Das informed us that the matter is being settled with the lodger of 100 and the balance 1500 shares of Re. 1/- each to be retained at our end as he was not able to contact the lodger Mr. Krishna Kumar Goenka.
